WILLS, BEQUESTS AND LIVING TRUSTS

BENEFICIARY DESIGNATION FOR IRAS AND OTHER RETIREMENT PLANS

We recommend calling your plan administrator's customer service department to direct you to the beneficiary form.

On the beneficiary form, decide what percentage (up to 100%) you would like us to receive and name Connor's Heroes Foundation as the beneficiary. Use our Federal Tax Identification number: 20-4992632 in place of a social security number.

BANK ACCOUNTS

Name Connor's Heroes Foundation as the beneficiary of a bank account. Close your bank account, and donate the funds.

LIFE INSURANCE

- This gift is as simple as updating your beneficiary designation form with the policy holder. You can designate Connor's Heroes Foundation as the primary beneficiary for a percentage or specific amount. You can also make us the contingent beneficiary so that Connor's Heroes will receive the balance of your policy only if your primary beneficiary does not survive you.
- Make an outright gift of an existing policy: You can name Connor's Heroes as owner and beneficiary of an existing policy as well as take out a new policy and irrevocably name Connor's Heroes as owner and beneficiary of the insurance contract
